## Proof of Vaccination or Negative Test for Entry to Tournament Venue

All attendees taking part in this event (competition/clinic/camp), including but not limited to athletes, parents, coaches, officials, medical staff, spectators and more must undertake the following procedures prior to entry:

- ◆ Sign the COVID19 Event Participation Waiver
- ◆ Complete and submit the Self Declaration every day prior to entry into the venue.
- ◆ All attendees must, upon arrival at the event venue, present proof of having received the full series of an accepted COVID19 Vaccine or a combination of Government of Canada-approved vaccines.
- ◆ The last dose of vaccine must have been received at least 14 days prior to the event.
- ◆ Acceptable forms of proof of vaccination include: electronic or printed public health issued vaccine printout for a full series of vaccines or a printout or QR code from MySaskHealthRecord or viewable in Sk Vax Wallet app, which indicates that the bearer is fully vaccinated.
- ◆ All attendees who do not have complete vaccination records can choose to provide a negative test result from no earlier than 72 hour prior to the first day of competition.
- ◆ Youth who are of an age (currently under age 12 years) where they are not eligible for vaccination, must provide a negative test result from no earlier than 72 hour prior to the first day of competition.

**Failure to provide either documentation will result in a denial of entry into the venue and participation in the event.**

### Vaccination Records:

- ◆ The fastest way to obtain them is through setting up a [My Sask Health Record](#) Account (click the link) If it is a new account your information will show up within 48 hours. This version will have a QR code so that no other personal information is available except your name and vaccination status.
- ◆ You can bring a printout from a local Public Health Office, there is a wait for these and a \$20 charge per record
- ◆ You can bring the wallet card you were provided at your 2nd vaccination appointment
- ◆ You can show your record on the [SK Vax Wallet app](#) which shows your QR code from your My Sask Health Record app. You are able to load the entire family's My Sask Health Record COVID vaccine report in to your vax wallet.
- ◆ You can show a screenshot of any of the above as long as it shows a scannable QR code or both vaccine dates, and your name.
- ◆ Staff at the entry can use the [SK Vax Verifier](#) app to scan your QR code and it will turn red if not vaxxed and green if fully vaxxed.

### Negative test results:

**NOTE:** we are not able to accept rapid test results from tests performed at home as they will not have an official result record. Though we encourage anyone with access to rapid test daily during the event if they wish, as an added layer of protection.

- ◆ Negative tests must be recent, that is must be done no earlier than 72 hours prior to 8am on the start day of the event. Ex: if attending Saturday must be done on the wed, thurs, or fri prior
- ◆ Options for negative tests depend on where you are living. Saskatoon and Regina have several private companies. Many other communities only have drugstores as an option. See [Where to Test](#).
